Thank you for your interest in participating in Lake Metroparks' 2016/2017 Deer Archery Season Controlled Hunt Program. Before proceeding, please note that applicants **MUST** be Lake County residents or business owners and a minimum of 18 years of age. Lake Metroparks employees and immediate family members residing within the employee's household are not eligible. Limit of one application per person.

Program participants may name a "partner" for their own stand and group assignment. The designated "partner" will be allowed to hunt only when the primary participant chooses not to hunt. The "partner" is required to fill out this partner application, pass the proficiency test and attend the mandatory meeting with their primary program participant before they can hunt. The "partner" is required to bring their proficiency test and completed application with them to the meeting.
