Lake Metroparks employees and immediate family members residing within the employee's household are not eligible. Limit of one application per person.

Program participants may name a "partner" for their own stand and group assignment. The designated "partner" will be allowed to hunt only when the primary participant chooses not to hunt. The "partner" is required to fill out this partner application, pass the proficiency test and attend the mandatory meeting with their primary program participant before they can hunt. The "partner" is required to bring the completed application to the meeting.
